The Heritage Conservation Committee vide its meeting dated 11/06/2019 recommended as follows:

The Heritage Conservation Committee vide its meeting dated 20/02/2019 has recommended the following:

The captioned premise is included in the Grade-IIA Heritage property list along with 20B & 20C, Karl Marx Sarani, noted for Building associated with 'Eminent Personalities, House of Michael Madhusudan Dutta'.

In case of Grade-IIA Heritage Building, no external change will be permissible and use of the building should also be compatible with the category of the Heritage building. But, new construction may be allowed in the open land within the premises in compatible manner with the Heritage building. In no case new construction should obstruct the view of the Heritage building.

The premises at 20A, Karl Marx Sarani have been demolished without any intimation to KMC. Accordingly, complain was lodged before Watgunge Police Station vide Memo No. PMU/319/18-19 dated 04/02/2019 & intimation given to DG (Building). The building at 20A & 20C, Karl Marx Sarani is located on the backside of 20B, Karl Marx Sarani. The premises 20B & 20C, Karl Marx Sarani remains intact.

Now, the matter is placed before the Heritage Conservation Committee for kind observation please.
