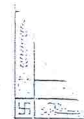


Resolution of the Heritage Conservation Committee meeting held on 20/09/2019

The Heritage Conservation Committee on its meeting dated 11/06/2019 and 11/08/2018 recommended as follows:

This is a case of Mutation due to transfer except under Co-operative Societies Registration Act and WB Apartment Ownership Act. Assessment Collection Department (N) forwarded the file. Total covered area of the flat/portion is 1336.4 sqft.

The captioned premises is recorded under 'Grade-Pending' category noted for 'Cultural particularly religious/ Mosques'.

Now, the matter is placed before the Heritage Conservation Committee for observation please.

Now, the matter is again placed before the Heritage Conservation Committee for further decision please.
