7	Where there will be no mention of number of seats, it will be calculated by taking 4 (Four) Sq.Ft. as one Seat (i.e. Number of seats = Total Area in Sq.Ft. / 4)
8	For Closure of any Permission, <b>on payment of outstanding demands, approval of Chief Manager (Amusement) will be required after due verification of documents as well as physical enquiry.</b>
9	For writing off any Demand for any 'Closed Establishment' / 'Not Found Unit', proposal is to be placed by Amusement Department <b>for approval of Corporation u/s 229 of KMC Act, 1980 after due verification of documents as well as physical enquiry.</b>
10	<b>No Amusement Fees is required to be paid for KMC owned Community Hall as it is rented at subsidized rate for the benefit of citizen as a part of social responsibility.</b>
