**Chief Manager (P)'s Circular No. 45/VIII of 2021-22**

**Sub: Removal of anomalies in the pay scale of Officers under Kolkata Municipal Corporation Legal Service.**

With reference to the U.O.No. Gr. P1/2020-21/0040, dated 28.05.2020 of Finance Department, Govt. of West Bengal, communicated through letter no. 124/MA/O/LSG/CC/2B-1/2019, dated 02.07.2020 issued by the Joint Secretary to the Government of West Bengal, Urban Development and Municipal Affairs Department (Municipal Affairs Branch) and in view of the upgradation of the pay scale for the post of Assistant Manager (Law) under Kolkata Municipal Corporation Legal Service, from pre-revised scale No. 15 to scale No.16 w.e.f. 16.08.1996 as per order of the Hon'ble Court, in order to distinguish the pay scale of promotion post from its feeder post, the scale of pay for the post of Dy. Chief Municipal Law Officer / Dy. Manager (Law) under Kolkata Municipal Corporation Legal Service is upgraded in the following manner:

- i. ***PB – 4A Rs.15,600-42,000 with grade pay of Rs.5,640/- with minimum pay at Rs.16,930/- under WBS(ROPA) Rules, 2009 w.e.f. 01.01.2006 notionally and***
- ii. ***Corresponding level 16A of schedule II of WBS (ROPA) Rules, 2019 w.e.f. 01.01.2016 notionally with actual effect from 01.01.2020.***

Necessary rectification in the Schedule of Establishment, in HR and other documents in this regard will be made accordingly.
