The Ramakrishna Mission Institute of Culture, Golpark enjoying exemption of property taxes for a period of 6 (six) years from 1st February '13 as per recommendation of HCC vide its meeting dated 27/07/2015 and approved by MIC vide Item No.M 17.6 dated 11/02/2016. The said agreement, made between the Kolkata Municipal Corporation and the Ramakrishna Mission Institute of Culture has expired on 31st January '19. Now, the Secretary of Ramakrishna Mission Institute of Culture has applied for extension of the said agreement for further 6 (six) years.

Of Late, the Secretary of Ramakrishna Mission Institute of Culture submitted an application to carry out minor repairing work including plastering & painting as some cracks are developed on the exterior wall and on some portions of the Chazza due to exposure to sun and rain. The work will be executed by engaging outside labour under the supervision of Maintenance department of Ramakrishna Mission.

Since, the Ramakrishna Mission Institute of Culture is 'Grade-I' Heritage property, the matter is placed before the Heritage Conservation Committee for observation please.
