Municipal Commissioner's Circular No. 12 of 2020-21

Sub.: Amendment of Rule 22(c) of the GPF regulation of the Kolkata Municipal Corporation

As communicated by the Joint Secretary to the Govt. West Bengal, Dept. of Urban Development & Municipal Affairs (Municipal Affairs Branch) vide Memo No. 117/MA/O/C-4/1A-27/2019, dated: 07.02.2020 (Copy enclosed), a notification prepared by the said Department shall be duly circulated to all concerned.

In exercise of the power conferred by Section 20, read with Sections 602 and 604, of the Kolkata Municipal Corporation Act, 1980 (West Ben. Act LIX of 1980), the Corporation, with the approval of the State Government, hereby makes the following amendment in the General Provident Fund (The Kolkata Municipal Corporation) Regulations (hereinafter referred to as the said regulations):-

*Amendment*

In the said regulations, for clause (c) of regulation 22, substitute the following clause:-

"(c) When the total amount payable on the subscriber's account does not exceed rupees two lakhs, the Manager may make payment to any person who may appear to the Manager to be member or members of the subscriber's family and/or legal heir of the subscriber, subject to furnishing an indemnity bond indemnifying the Corporation for an amount which is double of the amount to be payable."
