**Sub : Redesignation of the post of Superintending Medical Officer (General) under Hospital & Dispensaries in Pay Band 4A- Rs.15,600- 42,000/- plus Grade Pay Rs.6,600/- under Health Deptt., KMC to the post of Executive Health Officer in Pay Band 4A- Rs. 15,600- 42,000/- plus Grade Pay Rs. 6,600/- under Health Deptt., KMC**

Corporation in its meeting dated 18.01.2020 (vide Agenda No.58<sup>th</sup>, Item No. 11) has approved the recommendation of the Mayor-in-Council dated 30.12.2019 (vide Item No.MOA-93.11) for redesignation of the post of Superintending Medical Officer (General) under Hospital & Dispensaries in Pay Band 4A- Rs.15,600-42,000/- plus Grade Pay Rs.6,600/- (Pre-revised) to the post of Executive Health Officer in Pay Band 4A- Rs.15,600-42,000/- plus Grade Pay Rs. 6,600/- (Pre-revised) under Health Deptt., K.M.C. subject to necessary ratification by the State Government and for giving effect of such redesignation in anticipation of pending ratification by the State Government.

Accordingly the redesignated post is excluded from the Superintending Medical Officer (General) Cadre in Pay Band 4A – Rs.15,600-42,000/- plus Grade Pay Rs.6,600/- (Pre-revised) and is included under the Executive Health Officer Cadre in Pay Band 4A – Rs.15,600-42,000/- plus Grade Pay Rs.6,600/- (Pre-revised) under Health Deptt. as under :
