Municipal Commissioner's Circular No. 166 of 2019-20
Sub.: Revised Circular on Cleaning and proper illumination in bus stands

- I. In continuation of Municipal Commissioner's Circular no.158 of 2019-20, dated 10th February, 2020 those bus stands which have been constructed from the MPLAD/BEUP fund should be cleaned on weekly basis by deploying WBUES workers (100 days' worker). D.G.(Civil) is requested to direct the Borough Executive Engineers to monitor the cleaning works of the bus stands. D.G. (Bustee Dev.) shall take necessary action for installation of separate mobile toilets for Gents & Ladies behind the bus stands having proper lighting arrangement and water supply.
- II. For bus stands which are maintained by advertisement agencies, weekly cleaning of the bus stands shall be done by the advertisement agencies. Installation of separate mobile toilets for Gents & Ladies behind the bus stands shall also be done by the advertisement agencies. Ch. Manager (Advertisement) is requested to take necessary action in this regard.

Sub.: Cleaning and proper illumination in bus stands

Ch. Manager (Advertisement) shall engage external agencies for proper maintenance of bus stands including cleaning and adequate illumination.

As desired by KMC authority, separate mobile toilets for gents and ladies are required to be installed behind the bus stands wherever feasible. The mobile toilets must have water and lighting arrangement. OSD (EWS) is requested to take necessary action for supply of mobile toilets after consultation with Ch. Manager (Advertisement).
