Municipal Commissioner's Circular No. 17 of 2021-22

It has been decided by the KMC authority that the list of all permissible Covid Vaccination Centres (CVCs) should be made readily available in the public domain. While such list is maintained by Health & Family Welfare Department, GoWB for the state, list of CVCs of Kolkata shall also be maintained at KMC portal i.e. [https://www.kmccgov.in/KMCCPortal/downloads/Mega\\_centres\\_running\\_under\\_KMC.pdf](https://www.kmccgov.in/KMCCPortal/downloads/Mega_centres_running_under_KMC.pdf), [https://www.kmccgov.in/KMCCPortal/downloads/List\\_Covishield\\_CVC\\_KMC.pdf](https://www.kmccgov.in/KMCCPortal/downloads/List_Covishield_CVC_KMC.pdf) and [https://www.kmccgov.in/KMCCPortal/downloads/List\\_Covaxin\\_CVC\\_KMC.pdf](https://www.kmccgov.in/KMCCPortal/downloads/List_Covaxin_CVC_KMC.pdf). It has also been decided to make the list of CVCs available in the Covid Vaccine Related (CVR) App. By sending WhatsApp to number 8335999000. There shall be a provision of displaying all CVCs, Mega Centres and CVCs at Private Hospitals. It will also be possible to verify by sending CVC code to the above number to get the detailed address.

It is, therefore, directed that nodal officer for vaccination for KMC Dr. Ranita Sengupta shall maintain the updated list of CVCs undertaken by KMC and Sri Joly Chaudhuri, WBCS (Exe.), Joint Secretary to the Govt. of West Bengal, Urban Dev. & Mpl. Affairs Department shall maintain the list of all private CVCs on a real time basis. All private hospitals are therefore, directed to ensure that name of the CVCs and CVC Code are prominently displayed at each of the CVCs. Any change at CVC level should be promptly intimated to Sri Joly Chaudhuri, WBCS (Exe.).
