Sub: Modification of Recruitment Regulations for the posts of Assistant Horticulturist and Arboricultural Overseer under Parks & Squares Department, KMC.

In exercise of the power conferred by section 20, read with sections 602 and 604, of the Kolkata Municipal Corporation Act, 1980 (West Ben. 
Regulations

The method of, and the qualifications required for, recruitment to the posts of Assistant Horticulturist and Arboricultural Overseer under Parks & Squares Department, under the Kolkata Municipal Corporation, shall be as detailed below:

| A. | (1) Name of the post | Assistant Horticulturist |

| | (2) Pay Scale | Unrevised pay scale PB-4A [₹ 15,600-₹42,000/-] + Grade Pay ₹ 5,400/- revised as Level 16 as per ROPA 2019; |
| | (3) Method of Recruitment | 50% of the posts shall be filled up by direct recruitment through West Bengal Municipal Service Commission and 50% of the posts shall be filled up by promotion from the confirmed Arboricultural Overseer with seven years experience in the said post; |
| | (4) Qualification for direct recruitment | Bachelor Degree with Honours in Botany or Bachelor Degree in Agriculture from a recognized University or its equivalent and five (5) years experience in Horticulture works in a reputed Horticulture Nursery or Firm. |
| | (5) Age | Not more than 36 years on the 1 st January of the year of advertisement, relaxable for the candidates belonging to the categories of Schedule Castes, Scheduled Tribes and Other Backward Classes, Physically Challenged, PWD and any other category candidates as per Government orders/rules etc. for the time being in force; |

| | (5) | Age | Not more than 39 years on the 1 st January of the year of advertisement, relaxable for the candidates belonging to the categories of Schedule Castes, Scheduled Tribes and Other Backward Classes, Physically Challenged, PWD and any other category candidates as per Government orders/rules etc. for the time being in force; |


