**Sub: Requirement of approval of Government-constituted Tender Committee.**

In continuation of Municipal Commissioner's Circular no. 74 of 2016-17 dated 18/02/2017 it may also be noted by all concerned that in pursuance of the Notification No. 908/MA/C-10/3C-1/2017 dated 20/07/2018 of Urban Development & Municipal Affairs Department, Government of West Bengal, (copy enclosed) the State sponsored Development Schemes and Centrally sponsored Schemes like, MNB/SBM, JNNURM, NULM, NUHM, Abattoir etc., being implemented by KMC which are beyond 4.0 (four) Crore, will further require the approval/recommendation of Government-constituted Departmental Tender Committee/Technical Committee.

The single Departmental Tender Committee /Technical Committee has been constituted by the State Government vide Notification no. 908/MA/C-10/3C-1/2017 dated 20/07/2018 of the UD & MA Department, GoWB, in terms of Finance (Audit) Department Notification No. 925-F(Y) dated 14-02-2017.

All concerned Controlling Officers are requested to comply with the said Notification.
