Municipal Commissioner's Circular No. 59 of 2023-24

Re: Roll out of new Finance system including CRN and Contractual Employee Management System under eKMC 2.0 Project from WBSDC.

For roll out of new Finance system including CRN and Contractual Employee Management System under eKMC 2.0 Project from WBSDC, the following decisions have been taken.

1. From April 2024, the Finance System along with the CRN module under the existing KMC 1.0 Application shall be decommissioned, and the new Finance system under the KMC 2.0 system along with the Contractual Employee Management System shall be launched at the WBSDC from April 2024.
2. The KMC 2.0 Finance System shall include the functionalities of the CRN module of the existing Finance System. CRN for all KMC Departments for all types of funds (Government and Revenue) shall be generated from the KMC 2.0 Finance System.
3. The KMC 2.0 Finance System shall also include the provision for bill generation for all the procurement/service/supply etc. activities of KMC which also does not require the issuance of a work order.
4. For the time being, the existing ERP system shall be used up to bill generation for Purchase Order (P.O.) based work orders and the generated bills shall be transmitted to the KMC 2.0 Finance System for onward generation of CRN and further bill processing and payment. Once the KMC 2.0 Engineering Module is implemented in due course, bill generation for PO based work orders shall be carried out through the KMC 2.0 Engineering Module, and the existing ERP System shall be decommissioned in next phase.

5. The Contractual Employee Management System shall streamline the payment of wages and other related functions for the contractual staff across KMC. Payment of wages for different types of contractual employees such as Central Pool, WBUES workers, Security Personnel, HHW, SSK, etc. shall be done through KMC 2.0 Finance system in an integrated manner.
6. As part of the preparatory activities for the rollout of KMC 2.0 Finance System, the Finance System shall not be available from 1st April 2024 to 11th April 2024. Therefore, Finance System, CRN will remain deactivated from eKMC 1.0 MAS and ERP system.
7. The Information Technology department shall provide the necessary ICT Infrastructure to the Finance Department for accessing the KMC 2.0 Finance System.

All Controlling Officers are requested to take note of the above changes.
