Municipal Commissioner's Circular No. 86 of 2019- 2020

**Sub:- Arrangement to be made at different Ghats along the river Ganga and also at different waterbodies for 'Tarpan' on Mahalaya i.e. 28.09.2019.**

While arrangements have already been made for cleaning all the immersion ghats on the river Ganga to facilitate 'Tarpan' on the day of 'Mahalaya' on 28.09.2019, different departments will take the following action on 28.09.2019 from early morning upto the end, for smooth performance of 'Tarpan' not only on all the ghats along the river Ganga but also on the different waterbodies where such rituals are performed.

Names of main ghats along the river Ganga are Bichalighat, Doi Ghat, Judges Ghat, Baja Kadamtala Ghat, Rani Rashmani Ghat, Jaganath Ghat, Nimtala Ghat, Ahiritola Ghat, Nather Bagan Ghat, Chapatola Ghat, Kumartully Ghat, Bagbazar Ghat, Mayer Ghat, Dilarjang Ghat, Sarbamangala Ghat and Ratan Babu Ghat.

Arrangements to be made:-

1. **Lighting Department** :- DG (Ltg) will ensure proper manning at all the ghats so that 'Tarpan' at all the ghats can be performed without any hindrance.
2. **SWM Department**:- DG (SWM) will ensure cleaning of the approaches of all the ghats and ensure deployment of adequate staff at all the ghats for immediate response, if required, to perform 'Tarpan' smoothly.
3. **Engineering Department**:- DG (Civil) will ensure manning at all waterbodies at different boroughs especially from Br. XI to XVI where 'Tarpan' is performed at different waterbodies.
4. **Parks and Squares Department**:- DG (P&S) has already taken action for cleaning of all the immersion ghats along the river Ganga and also deputed staff at different ghats to oversee smooth performance of 'Tarpan'. Copy of Office Order of DG (P&S) dated 26.09.2019 enclosed herewith.
5. **Municipal Secretary's Department**:- Municipal Secretary will ensure deployment of disaster management staff at all the ghats to prevent any untoward situation or incident that may happen during 'Tarpan'.
