Municipal Commissioner Circular No. 26 of 2019-20

Sub: Modification to the existing Recruitment Regulations for the post of Sub-Registrar in the pay scale PB – 4 (₹9,000 - ₹40,500) + GP ₹4,700/- under Health Department, KMC

In exercise of the power conferred by Section 602, read with Sections 20 and 603, of the Kolkata Municipal Corporation Act, 1980 (West Bengal Act LIX of 1980), in supersession of all earlier Regulations on the subject, Governor is hereby pleased to accord approval, with immediate effect for the following regulations regulating the recruitment to the post of Sub-Registrar under the Health department of the Kolkata Municipal Corporation, namely:-

Regulations

The method of, and the qualifications required for, recruitment to the post of Sub-Registrar under the Health department of the Kolkata Municipal Corporation, shall be as follows

Qualifications: 1. A degree/diploma in Homeopathic Medicine like BHMS, DMS from a recognized University/Institution. 2. Age not more than 35 years on the 1 st January of the year of advertisement, relaxable for well experienced candidate.	“Essential Qualifications” 1. A degree/diploma in Homeopathic Medicine like BHMS/DHMS/DMS from a recognized University/Institution. 2. Age not more than 45 years on the 1 st January of the year of advertisement
	Desirable Qualification: Experiences of working for three (3) years in Government/Semi-Government/Local/Statutory Bodies/Urban Local Bodies on either permanent or contractual basis in Burning Ghats/Burial Grounds /Mortuary, etc.
