


As per the decision of Town Vending Committee meeting dated 01.11.2022, survey was commenced from the end of TVC initially in Gariahat, Hatibagan and New Market areas. Initial Survey report of the Gariahat Market and Hatibagan Market and ongoing survey of New Market area has been placed before the Town Vending Committee. The format of notarised affidavit declaration to be submitted by the hawkers/vendors for obtaining Certificate of Vending and some rules/modalities for obtaining such Certificate of Vending was also discussed in the TVC meeting.

In the aftermath of discussions and suggestions received from the TVC members present, the following decisions have been taken in the meeting of Town Vending Committee:-

- a. The entire list of Hawkers applicants of 2014-15 have been published in KMC web portal. In the present situation, Certificate of Vending to be issued to those hawkers vendors only who have applied in 2014-2015 (whose names are found to be published in KMC web portal) and are also found to be present during the present survey. Such Certificate of Vending to be issued to the eligible hawkers/vendors by Licence Department, KMC. Eligible Hawkers/vendors shall submit application in prescribed format (copy enclosed) along with notarised affidavit declaration (copy enclosed) and a photo ID (EPIC/Aadhaar). This process shall start after completion of present survey in Gariahat, Hatibagan and New Market areas in totality and acceptance and finalisation of current report by the TVC.
- b. After successful completion of the process of survey in Gariahat, Hatibagan and New Market areas, the process will be implemented in remaining other hawking/vending zones areas of Kolkata in phases as decided by the TVC in future.
- c. Presently the survey has been extended up to 7.12.2022. It has been decided that Survey work may be continued after 7.12.2022 as may be required for completion of the survey in a fruitful manner. For that matter the members of TVC, KP team and KMC team may coordinate over phone.
