Pursuant to the decisions of the previous TVC meetings and subsequent suggestions received from the TVC members present and discussion held in the TVC meeting on 04/10/23, the following valuable decisions are taken:-

- a. Town Vending Committee will be reconstituted as per guidelines of the West Bengal Urban Street Vendors Rules 2018 duly published on the Kolkata Gazette [Notification No. 461/MA/O/C-4 /1A-10/2011(Pt.II), Dated 27th June, 2018].
- b. 'Vending Zone' & 'Non Vending Zone' across the city of Kolkata will be determined shortly on the recommendation of TVC after obtaining joint survey report from the Borough Ex. Engineers (Civil) and the Asst. Directors of SWM Department.
- c. In the event of death of the existing street vendors whose names are enlisted in KMC portal or the street vendors who submitted application for their enlistment in the year 2015, 'Certificate Of Vending' for running the stall will be issued to the legal heir(s) of deceased street vendors on





submission of the application accompanied by valid documents of heirship. Even Certificate issued by concerned Councillor will be treated as valid documents of legal heirship.

- d. Illegal encroachment around Oberoi Grand Hotel, 15 Jawaharlal Nehru Road , Kolkata -700013 will be removed to ensure 2/3rd of the pavement is free for pedestrians movement, following the guidelines as stipulated in MIC Agenda Item No -31.74 , dt – 28/08/2023 and SWM Department will take necessary action for the same in presence of the officials from DG (Civil), Buildings and Market Department and with the help of local Police Station.
- e. A joint survey shall be executed by the TVC members and officials of DG (Civil), Buildings, Market and SWM Department at the stretch from Bipin Behari Ganguly Street to Sealdah Station along with local police on 12/10/2023.
- f. All complaints enquired by the team of TVC members constituted on the recommendation of earlier TVC Meeting, and the report is duly accepted in this meeting and it has been decided to resolve the complaints as per the extant rules. Henceforth, all such complaints will be disposed of as per the West Bengal Urban Street Vendors (Protection of Livelihood and Regulation of Street Vending) Rules, 2018.
