
Pursuant to the decisions of previous TVC meetings, subsequent suggestions received from the TVC members present and discussion held in the TVC meeting held on 07/07/2023, the following valuable decisions are taken:-

- Certificate of Vending (COV) will be issued to 19 nos. of hawkers (New Market-5, Gariahat-4, and Shyampukur-10) as per previous decision taken on last TVC meeting on 16.03.2023 after finalization of applicable fees structure from the end of Govt of West Bengal.
- Only application regarding the inclusion of New Member of TVC from State Committee of Central Trade Union under the signatory of Secretary / President may be placed/ entertained of TVC meeting. No Member from any unit/area/segment will be entertained for incorporation of membership in TVC.
- Action will be taken against illegal occupation of place in front of bona fide trade establishment.
- Process for beneficiaries under the Scheme PMSY will be started primarily with the hawkers enrolled on web portal of KMC basis the list of 2015.
- If any question arises regarding inclusion of illegal hawkers, then one concerned member from TVC, one member from Market Department, KMC and one from Kolkata Police will enquire about it. The Report will be placed in TVC for further decision. No New hawker beyond the list of 2015 will be granted for hawking in KMC area. In case of New Market, Gariahat, Hatibagan current survey report will be enforced for such hawking in these area.
