Pursuant to the decisions of previous TVC meetings and subsequent suggestions received from the TVC members in the TVC meeting held on 11/08/23, the following valuable decisions are taken:-

- a. A committee with four groups (namely North, South, East & Central) has been formed to address and resolve the complaints in connection with encroachment by hawkers which are placed in TVC meeting. Each group will be constituted with one member from Kolkata Police, one from Traders' Association body and one from Hawkers Association body representing TVC and one employee from Market Dept of KMC. The TVC members representing Hawkers Association are 1) Asit Saha 2) Bharat Sah 3) Debasish Das 4) Murad Hossain 5) Rekha Marik 6) Ashok Chakraborty 7) Saktipada Mondal 8) Royal and the representative from Traders are 1) Subhendu Ghosh 2) N K Saha 3) Uday Shaoo 4) Rajesh Pandey. The complaints will be enquired by the committee and will place their report in subsequent TVC Meeting.
- b. Application regarding the inclusion of New Member of TVC from State Committee of any central trade union will be placed before MMIC (P&S) for verification and subsequent decision for inclusion as invitee member.
- c. No hawkers will be allowed to trade within 10 feet from public places, bus stop, gates of offices and hospital, public building, congregation or worship area for public or any such place considered not suitable for vending activities.
- d. There will be no hawking zone within the ambit of 50 feet in respect of 58 major Road Crossings and other important crossings as to be decided in subsequent TVC meetings.
- e. A team headed by MMIC (P&S) will visit on 03.09.23 to enquire the present status of encroachment by street hawkers nearby Kolkata Medical College.
- f. At present Identity Card will not be issued to any TVC member however the list containing names of TVC member has been already sent to all Police Stations under the jurisdiction of KP for their information.



- g. Enlisted hawkers may apply on KMC portal for ~~PNAS~~ with the help of BSK and under the guidance and supervision of Market Dept, KMC.
- h. Besides nineteen hawkers who will be issued Certificate of Vending today itself, all the hawkers whose name figure in KMC portal wherein the list was prepared based on their application followed by survey conducted in the year 2015 and those who are continuing their same business on the same place will be issued Certificate of Vending by Licence Department.
- i. It has also been decided that the hawkers who had genuinely submitted application for their enlistment in the year 2015, however somehow their names were left out from inclusion in the list available in KMC portal; their cases will be placed further before TVC for decision regarding inclusion of their names followed by issue of Certificate of Vending.
