

MINUTES OF THE MEETING OF TOWN VENDING COMMITTEE FOR KOLKATA CITY, HELD ON 14TH JANUARY, 2022 IN THE COUNCIL CHAMBER.

The direction issued by the Hon'ble High Court, Calcutta, is also enclosed.

Municipal Secretary, KMC submits that the terms of previous Town Vending Committee ceased as per the provision of rule 6 of the West Bengal Urban Street Vendors (Protection of Livelihood and Regulation of Street Vending) Rules, 2018. Thus, there is a need for re-constituting the new Town Vending Committee. He reads the relevant guidelines as enshrined in section 22 of the Street Vendors (Protection of Livelihood and Regulation of Street Vending) Act, 2014 and rules made thereunder.

In the after-math of detailed deliberations from the attendees of the meeting and provisions as stated above, a new Town Vending Committee is formed consisting of the following members :

- 1) The above formation is made keeping with the provision of law i.e. the percentage of women vendors, number of members in the Town Vending Committee, number of nominated representative of the street vendors.
- 2) Claims of settlement, if any, on this list may be submitted within 15 (fifteen) days from the date of uploading of the list to the office of the Municipal Secretary, K.M.C.
- 3) The members of the Town Vending Committee are also requested to submit their claims, objection, suggestion, if any, on the list of 56 (fifty six) thousand vendors and the Survey report of the Kolkata Police within 15 (fifteen) days from the date of uploading.
- 4) Detailed discussion was held about the other function of the Town Vending Committee as laid down in rule 9 of the West Bengal Urban Street Vendors (Protection of Livelihood and Regulation of Street Vending) Rules, 2018.
- 5) After detailed discussion it was decided that each member of the newly constituted Town Vending Committee shall give their written suggestion on each point within 7 (seven) days from the issue minutes of the today's meeting.
- 6) The next meeting of the Town Vending Committee shall be held on 24.02.2022.
