


Pursuant to the decisions of previous TVC meetings, subsequent suggestions received from the TVC members present and discussion held in the TVC meeting held on 16/03/2023, the following valuable decisions are taken:-


- a. Preliminary survey of hawkers has already been completed in three Vending Zone i.e in New Market area, Gariahat area and Hatibagan area. Out of these three vending zones 1/3 footpath area of different streets under Gariahat zone have already been earmarked as vending Zone and remaining 2/3 area of the footpath have been earmarked as Non-Vending Zone. The process of Identification of other vending zones under the jurisdiction of KMC will be completed subsequently.
- b. Certificate of Vending (COV) will be issued to 19 nos. of hawkers (New Market-5, Gariahat-4, Shyampukur-10) after finalization of applicable Fee Structure in TVC meeting.
- c. There will be fixed one time processing fees of Rs.500/- only against issue of Certificate of Vending (COV) as suggested by TVC representatives from

- different Hawkers' Union and yearly User fees will be decided by TVC after receiving suggestion from TVC members representing the hawkers.
- d. It has been decided in the meeting that Identity Card will be issued to the permanent members of TVC by Chairman, Town Vending Committee.
 - e. SUDA (State Urban Development Authority) will be approached after consultation with General Secretary of Hawker Sangram Committee for sanction of applicable Conveyance allowance for permanent members of TVC.
 - f. It has also been decided that the office of TVC will be setup at Roxy Building, 4A, Chowringhee Place, Kolkata-700069. Requisite manpower for the same will be provided by the Personnel Department primarily from Licence, Market and also from other Departments.
 - g. Ravi Saha, General Secretary, Ballygunge Hawkers Association of 26B, Fern Road Kolkata-700019 has been inducted as new member of Town Vending Committee.


