

Pursuant to the decisions of previous TVC meetings and subsequent suggestions received from the TVC members present and discussion held in the TVC meeting on 20/12/23, the following valuable decisions are taken:-

- a. Survey report by SWM Dept. & CME (Civil) Dept. for the purpose of determination of 'Vending Zone & Non Vending Zone' will be sent to all TVC members in soft copy for their recommendation of the same.
- b. No footpath having lesser than 5 ft width will be declared 'Vending Zone'.
- c. For rehabilitation of evicted street hawker at Mallickbazaar [in the case of WPA(P) 264 of 2023 Faizan MD. Zafar Vs The State of West Bengal & Ors] a letter will be sent to the concerned Police Station as well as the petitioner seeking information regarding list of hawkers along with their details.
- d. Joint action by New Market Police Station, CME (Civil) Dept, SWM Dept and Market Dept of KMC will be held for demarcation of 1/3 of footpath around the CMO building of KMC to prevent illegal hawker encroachment very soon in view of the order of Hon'ble Court in WPO(P)/9/2021 (Akshaya Kumar Sarangi Vs The State of West Bengal and Ors).
- e. The four hawkers adjacent to Premises no 152, Rabindra Sarani, Ward No 041, Br V will be shifted to nearby location temporarily by SWM Dept with the help of concerned Police Station until repair of the said building. TVC members will be present to facilitate the shifting.
