Pursuant to the decisions of previous TVC meetings and subsequent suggestions received from the TVC members in the TVC meeting held on **12/03/2024**, the following decisions are taken:-

1. As per order of Hon'ble High court in case no WPO/1885/2023 in the matter of Tridhara Construction Vs Kolkata Municipal Corporation and ORS, unauthorised hawkers at 111 College Street will be removed and relocated at any suitable place among three identified location i.e. i) 41, Eden Hospital Road ii) Kolutola Street and iii) 110, College Street after joint inspection by team comprised of TVC member, Official of CME (Civil) & SWM Dept. KMC and Official of Bowbazar Police Station. The date of joint inspection will be intimated to the official very soon.
2. Inclusion of Sri Swapan Samaddar (President of North Kolkata District INTTUC) and Sri Avijeet Mukherjee (president of South Kolkata District) as Member of TVC recommended by INTTUC have been accepted and they will replace existing members of TVC representing INTTUC.



3. All 1892 nos. street proposed as 'No Vending Zone' listed on official website of KMC are hereby declared as 'No Vending Zone'. A Notice will be published very soon in this regard.
4. No new hawkers will be allowed on footpath along with the S. N. Banerjee Road unless decided by TVC, Kolkata.
5. Street in front of CMO Building and adjacent to Chaplin Park is accepted as 'No Vending Zone'. The New-market police station will keep strict vigilance so that no hawker can occupy Black-top of the adjacent area of CMO building, KMC.
6. The submissions of General Manager, The Oberoi Grand Hotel through their counsel as well as Representation of 13 hawkers also through their counsel have been heard by the members of TVC. Further discussion in this regard will be held in the next meeting.
7. Joint inspection by team comprised of TVC member, Official of CME (Civil) & SWM Dept. KMC and Official of concerned Police Station will be arranged to resolve complain /application discussed on TVC meeting regarding unauthorised hawkers.
